Dear Abderrahmane Benguenab.,

After discovering your dishonest use of my 2014 scientific publication, your acknowledgment of this unethical behavior, and your apology, I want to clarify that I do not wish to harm your academic career, which is still in its early stages. To avoid escalating the situation, I strongly request the following from you:

1. Write an official letter of apology, including the names of those who participated with you and your own name, on your university's and research laboratory's official letterhead, and send it to me by email as an attached document.
2. Write to the journal where your article was published in 2024—listing your co-authors and yourself—and request the withdrawal of the article, explaining the reasons for the retraction.
